Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (k)(1)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Buffered State Water (BSW) B (roadside ditch that drains to Whitewater Creek). The project will install a new bridge along the current centerline with two 12-foot travel lanes and an 8-foot shoulder on each side. The project will impact the state mandated 25-ft buffer within the Upper Flint River watershed (HUC 03130005). The disturbance will cover 15,422 square feet and include widening of the existing roadway and related fill slopes, installation of a temporary detour truss bridge, construction access, drainage improvements, and the installation of Best Management Practices (BMPs).
