Description and Location of Proposed Activity:

Forsyth County proposes to permanently impact 65 linear feet (2,797 ft²) of a tributary of Baldridge Creek to construct a new roadway. The new roadway will run from SR 9 to SR 369 in Forsyth County. The road will be 1 mile in length with two lanes in each direction with a 12-foot raised median. The project also includes an 11-foot urban shoulder with curb and gutter, a 10-foot sidewalk on the north side and a 5-foot sidewalk on the south side.
