Description and Location of Proposed Activity:

The proposed stream bed and bank maintenance project aims to stabilize the eroding streambank along an unnamed tributary of the Chattahoochee River. The project is located within Three Chimneys Subdivision in Forsyth County and is part of the Upper Chattahoochee Watershed (03130001). Land disturbing activities will include placement and construction of rock vanes, accounting for a buffer disturbance of 150 linear feet (900 square feet). All disturbed areas will be revegetated upon completion of the two-week project.
