This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (d)

Description and Location of Proposed Activity:

The proposed project involves the installation of a new gravity sewer line. Disturbance of the buffer is necessary in order to avoid bisecting adjacent properties within the sewer line and easement. A Revegetation Plan and erosion control measures are implemented to address minor impacts. The proposed project is composed of 37 individual buffer encroachments resulting in 4,962 total linear feet (43,045 total square feet) of buffer disturbance lasting approximately 7 months. The project is located on Yellow Creek and an unnamed tributary of Yellow Creek of the Etowah Watershed (03150104).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
