Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Basis under which variance shall be considered $\{391-3-7-.05(2)(a-k)\}$: (d)

Description and Location of Proposed Activity:

The proposed project involves the installation of a new gravity sewer line. Disturbance of the buffer is necessary in order to avoid bisecting adjacent properties within the sewer line easement. A Revegetation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 1,260 linear feet (19,367 total square feet) of buffer disturbance lasting approximately 5 months. The project is located on an unnamed tributary to Settingdown Creek of the Etowah Watershed (03150104).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
