Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: h

Description and Location of Proposed Activity: The project proposes 0.40-mile of widening, shoulder grading, and reconstruction of the I-75 exit ramp at Northside Parkway NW, a portion of Northside Parkway NW between the I-75 exit ramp and Howell Mill Road NW, including 200-feet of merging lane onto Howell Mill Road NW in the City of Atlanta, Fulton County, Georgia. Changes will include restriping the northbound left turn lane at SR3/US 41/Northside Parkway and Howell Mill Road as a through/left turn lane and the construction of a second right turn lane on the I-75 northbound exit ramp.
