Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The first phase of the proposed project will consist of constructing a delivery station (warehouse facility) and associated infrastructure on approximately 86 acres along Marietta Road (formerly CSX Transportation Atlanta Terminal Tilford Yard) in Atlanta. This project will include an on-site stormwater management system (including a bioretention basin (with underdrain), four (4) enhanced dry swales (with underdrains) and five (5) micropool extended detention (ED) ponds). The proposed project will result in buffer impacts to approximately 299 linear feet total (14,727 square feet total) along an unnamed intermittent stream, a tributary to Proctor Creek in the *Middle Chattahoochee – Lake Harding Watershed*.
