Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Description and Location of Proposed Activity:

The proposed project will consist of constructing a new front-load warehouse facility and associated infrastructure on approximately 14.45 acres along Stonewall Tell Road in Union City. This project will include an on-site stormwater management system (including a wet stormwater pond with a *Hydro International Downstream Defender*® hydrodynamic vortex separator). The proposed project will result in permanent buffer impacts (22,304 square feet total) along approximately 407 linear feet of an unnamed intermittent stream, a tributary to Wolf Creek in the *Middle Chattahoochee – Lake Harding Watershed*.
