Description and Location of Proposed Activity:

The proposed project will consist of constructing a new multi-family residential development and associated infrastructure on approximately 3.37 acres along Roswell Road in Sandy Springs. This project will include an onsite stormwater management system (including bioretention basins without underdrains). The proposed project will result in buffer impacts to approximately 194 linear feet total (12,484 square feet total) of an unnamed perennial stream, a tributary to the Chattahoochee River in the *Upper Chattahoochee Watershed*.
