Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This project will construct an elevated ramp multi-use trail, with supporting infrastructure, to connect with an existing trail. The plan was designed with minimal buffer disturbance in mind; however, there are unavoidable areas of buffer disturbance due to existing property lines and topography. After construction the streambank will be replanted with multi-trophic native riparian vegetation placed in all practicable locations. The proposed project, planned for 24 months, will result in 145 linear feet (1,262 total ft²) of buffer disturbance located near an unnamed perennial stream in the Upper Ocmulgee Watershed (03070103).
