Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This project involves the construction of a medical center on 12.1 acres. During construction of the medical center and supporting facilities 343 linear feet (19,882 square feet) of buffer will be impacted with fill of an intermittent stream to support the proposed use. The proposed project is along an unnamed intermittent stream to the Chattahoochee River in the Upper Chattahoochee Watershed (03130001).
