This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Site plans are available for review and are located in the following EPD office: Watershed Protection Branch File Room, 2 MLK Jr. Drive, SW, West Tower, Balcony, Suite 418, Atlanta, GA 30334. Please contact GORArequest.Water@dnr.ga.gov to schedule an appointment to review the plans. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a, f, & i)

Description and Location of Proposed Activity:

The proposed infrastructure redevelopment and water quality project intends to connect the City of Johns Creek Town Center with a new green space amenity. Infrastructure related land disturbing activities include grading and construction of a multi-use trail, elevated boardwalks, and amphitheater amenities within the buffer of a tributary of Johns Creek. Water quality improvements include conversion of the existing open water ponds to wetlands and installation of permanent bioretention BMPs. Buffer disturbances total 72,077 square feet along 3,141 linear feet. The site is located within the Upper Chattahoochee Watershed (03130001). Completion of the year-long project will enhance the buffer to a functioning system and improve water quality.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
