Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed stream restoration project aims to address erosion and bank failures along an unnamed stream between McGinnis Ferry Road and East Johns Crossing in the city of Johns Creek, Fulton County. Land disturbing activities and stabilization practices include step-pool structure installation, bioswale implementation, riprap placement, and revegetation practices. Encroachments necessary for this project total 129,207 square feet along 1,500 linear feet within the buffer of an unnamed tributary of Johns Creek. The project is located within the Upper Chattahoochee Watershed (03130001).
