Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to remove invasive species and revegetate with native riparian species. An existing single-family dwelling will be remodeled, temporary perimeter erosion, sedimentation and pollution control BMPs and three separate additional landscaping impacts will require 309.2 total linear feet (7,730 total square feet) of buffer impact along an unnamed tributary to North Utoy Creek in the Middle Chattahoochee Watershed (03130002).
