This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Site plans are available for review and are located in the following EPD office: Watershed Protection Branch File Room, 2 MLK Jr. Drive, SW, West Tower, Balcony, Suite 418, Atlanta, GA 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (f)

Description and Location of Proposed Activity:

The proposed project intends to provide passive recreational components to Encore Greenway and Gateway Park in the city of Alpharetta, Fulton County. The multi-use trail and appurtenances will connect North Point Park to the existing Big Creek Greenway, south of the intersection of Encore Parkway and North Point Parkway. Land disturbing activities necessary for this project include clearing, grading, boardwalk and path placement, and BMPs. Encroachments total 11,694 square feet along 407 linear feet within the buffers of unnamed tributaries of Big Creek. The project is in the Upper Chattahoochee Watershed (03130001). The site will be revegetated with multi-trophic, native riparian species.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
