Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a) & (f)

Description and Location of Proposed Activity:

The proposed project involves the removal and replacement of existing structural stormwater management infrastructure with nature-based infrastructure, the restoration of stream channels, and the construction of a new boardwalk trail for public use. Disturbance of the buffer is necessary in order to convert the former golf course into a passive recreational park and nature preserve as a part of the City of Milton's Greenspace Plan, "The Greenprint". Project implementation will provide passive recreational opportunities for the public and promote the return of the landscape's natural hydrologic flow and function. A Buffer Mitigation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 884 total linear feet (10,983 total square feet) of buffer disturbance lasting approximately 6 months. The project is located on two unnamed impoundments and two unnamed tributaries to Chicken Creek of the Etowah Watershed (03150104).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
