Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

To ensure compliance with the *Georgia Safe Dams Act*, this project will consist of removing all inappropriate vegetation and the *existing* CMP outlet pipe, installing a *new* principal spillway riser and labyrinth weir auxiliary spillway system and regrading the slopes of the dam along Lake Louella at Suwanee Creek Road in Gwinnett County. All disturbed areas will be restored to current conditions to the extent practicable. The proposed project will result in approximately 406 linear feet total (10,787 square feet total) of buffer disturbances along Lake Louella and Bennett Creek in the *Upper Ocmulgee Watershed*.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
