Description and Location of Proposed Activity:

The proposed project will consist of constructing a new roundabout intersection along State Route 84 (Grayson Parkway) at Ridgedale Drive in Gwinnett County. Construction activities (including fill slopes) will result in approximately 161 linear feet total (2,549 square feet total) of buffer disturbances along an unnamed perennial stream, a tributary to Big Haynes Creek in the *Upper Ocmulgee Watershed*.
