Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed project will consist of constructing a multi-family residential development and associated infrastructure on approximately 5.20 acres along Scenic Highway South in Lawrenceville. This project will include an on-site stormwater management system (including underground detention and Hydro International Up-Flo[®] Filters with CPZTM Mix Filter Media). The proposed project will result in permanent buffer impacts (9,537 square feet total) along approximately 190 linear feet of an unnamed intermittent stream, a tributary to Pew Creek in the *Upper Ocmulgee Watershed*.
