Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed activity involves the construction and installation of a sidewalk and stormwater management system. Disturbance of the buffer is necessary in order to make improvements to connectivity and existing stormwater systems. A Revegetation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 25 total linear feet (223 total square feet) of buffer disturbance lasting approximately 7 months. The project is located on Jackson Creek (Gwinnett/DeKalb County Line to Sweetwater Creek segment) of the Upper Ocmulgee Watershed (03070103).
