This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the removal of accumulated sediment from Pounds Lake and the improvement of existing associated infrastructure. Disturbance of the buffer is necessary in order to return the impoundment to pre-existing conditions, capacity, and function. A Buffer Mitigation Plan and erosion control measures will be implemented to address major impacts to the buffer. The proposed project will result in 352 total linear feet (6,192 total square feet) of buffer disturbance lasting approximately 2 months. The project is located along Pounds Lake and an unnamed tributary of Pounds Lake of the Upper Ocmulgee Watershed (03070103).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
