Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The proposed project will consist of constructing a fuel and retail center and associated infrastructure on approximately 1.64 disturbed acres at the intersection of Sweetwater Road and Sweetwater Club Drive in Gwinnett County. This project will include an on-site stormwater management system (including one (1) stormwater pond with proprietary device, underground detention and permeable pavers). The proposed project will result in permanent buffer impacts (20,006 total square feet total) along approximately 373 linear feet of two unnamed perennial streams, tributaries to Sweetwater Creek in the Upper Ocmulgee Watershed (03070103).
