This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary for the construction of one distribution warehouse building and associated parking and infrastructure off of McBrayer Road. The project will require 11.974 acres of land disturbance including permanent impacts (pipe/fill) to 535.1 linear feet (28,886.4 total square feet) of State Waters buffer lasting approximately 1 year. The project is located on an unnamed tributary to Mud Creek of the Upper Chattahoochee Watershed (03130001). The project will incorporate water quality BMPs (permanent wet pond and proprietary system) to satisfy both water quality protection and hydrologic protection requirements.
