Activity

This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Site plans are available for review and are located in the following EPD office: Watershed Protection Branch File Room, 2 MLK Jr. Drive, SW, West Tower, Balcony, Suite 418, Atlanta, GA 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the construction of a new roadway from the existing intersection of North Carmel Road and Jonesboro Road to Flippen Road. Impacts to the State Waters buffer will occur only along the existing Jonesboro Road for the installation of a new right turn lane. Disturbance of the buffer is necessary in order to facilitate clearing for construction access, guardrail installation, road tapering, and the installation of erosion and sedimentation control best management practices. A Revegetation Plan and erosion control measures are implemented to address minor impacts. The proposed project will result in 14 total linear feet (253 total square feet) of buffer disturbance lasting approximately 18 months. The project is located on an unnamed tributary to Walnut Creek in the Upper Ocmulgee Watershed (03070103).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
