Description and Location of Proposed Activity: <u>The proposed project will impact the buffer of Perennial Stream</u> (PS) 6 (unnamed tributary to Mossy Creek). The project will convert the existing multiple stop-controlled intersection at US 129 and SR 247 to a three-leg single lane roundabout. The project will impact the state mandated 25-ft buffer within the Lower Ocmulgee River watershed HUC - 03070104. The disturbance will cover 4,723 square feet and include clearing impacts for construction access and the installation of Best Management Practices (BMPs).
