This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Description and Location of Proposed Activity:

Continued streambank erosion along the Mulberry River will eventually impact existing drinking water supply wells and utility easements located between Silk Tree Pointe and Liberty Church Road in Braselton. The proposed stream restoration and streambank stabilization project will consist of realigning the Mulberry River (i.e., constructing bankfull benches, installing log and rock j-hooks, sill logs, toe wood, log deflectors and constructed riffles), grading the streambanks along the Mulberry River to a more stable slope and live staking and plantings along the bankfull benches and terraces (including *Black Willow, Silky Dogwood, Tag Alder, Elderberry, Water Oak, River Birch* and *Red Maple* with native riparian seed mix). This project will result in approximately 5,254 linear feet total (523,157 square feet total) of buffer impacts along the Mulberry River in the *Upper Oconee Watershed*.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
