Dear Mr. Duff:

Your request and revised proposal relative to the referenced project have been reviewed. The revision requested in your letter is for a change in mitigation only. The proposed revision would allow for a change in mitigation credits from in-basin stream credit to out of basin stream credits.

This revision to a previously approved buffer variance will not affect the project's original concept, does not change the amount of buffer encroachments and is only a revision of the proposed mitigation.

Condition #5 is hereby revised as follows:

5) The applicant purchased 32 stream mitigation credits from the Primary Service Area (PSA) serving the same 8-digit HUC and from within a Secondary Service Area (SSA) serving the same 8-digit HUC. EPD received the sales receipt verifying the credit purchase by the applicant to document buffer mitigation compliance at least 14 days prior to any land disturbance on site. Proof of delivery and receipt is the applicant's responsibility.

The proposed revisions will not require further application to GAEPD. Conditions 1-4 and 6 specified in the attached July 14, 2023 approval remain in effect.

You remain obligated and responsible for complying with the provisions of any other law or regulations of any federal, local or additional State authority; however, the aforementioned are not obligated to permit this project if they do not concur with its concept of development/control.
