Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to construct a concrete public boat ramp. Disturbance of the buffer is necessary in order to improve river access for recreational purposes. A Buffer Mitigation Plan and erosion control measures will be implemented to address major impacts. Bioengineered stabilization practices include live-stakes and rip-rap joint plantings. The proposed project will result in 111 total linear feet (2,187 total square feet) of buffer disturbance lasting approximately 8 weeks. The project is located on Kinchafoonee Creek of the Kinchafoonee-Muckalee Watershed (03130007).
