This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed trail extension project involves expansion of the Follow Me Multi-Use Trail located adjacent to Fort Benning Army Base in Muscogee County. The new trail section would be constructed to connect the existing trail with a new roadway, Infantry Road. Land disturbing activities include clearing and grubbing, BMP placement, and fill placement within the buffer of an unnamed tributary to Upatoi Creek. Buffer encroachments total to 641 square feet along 62 linear feet within the Middle Chattahoochee Watershed (03130003). Disturbed areas will be stabilized and revegetated upon completion of the project.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
