Description and Location of Proposed Activity:

This proposed project will construct a recreational bike pump for public recreational use. The applicant proposes to encroach on three separate buffer impacts with 344 total linear feet (5,024 total square feet) of buffer along Weracoba Creek. The portions of the track located in the buffer will be composed of prefabricated concrete and bioretention areas to mitigate buffer functions. The project is along Weracoba Creek, in the Middle Chattahoochee-Walter F. George Watershed (03130003).
