Description and Location of Proposed Activity: <u>The proposed project will impact the buffer of Perennial Stream</u> (PS) 1 (Yellow River). The project will replace the bridge over Yellow River along Brown Bridge Road. The project will impact the state mandated 25-ft buffer within the Upper Ocmulgee River watershed (HUC 03070103). The disturbance will cover 800 square feet and include the construction of a multi-use path.
