Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a) & (h)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Open Water (OW) 4 (Snapping Shoals Creek Tributary), OW 5 (Snapping Shoals Creek Tributary), OW 9A (Caney Fork Creek Tributary), and OW 9C (Caney Fork Creek Tributary). The project will widen SR 162/Salem Road from two to four lanes from South of CR 511/Brown Bridge Road in Newton County to CR 55/Flat Shoals Road in Rockdale County. The project will impact the state mandated 25-ft buffer within the Upper Ocmulgee Watershed (HUC 03070103). The disturbance will cover 11,531 square feet and include placement of riprap for a culvert outlet and overflow spillway, clearing for construction access, fill, construction of a dry detention basin, reconstruction of an existing culvert outfall, and the installation of Best Management Practices (BMPs).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
