This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the demolition and replacement of an existing pond dam structure. The new pond dam structure, including a primary spillway, outlet control facilities, outlet pipe, outlet protection and a retaining wall will be constructed in compliance with the Georgia Environmental Protection Division's Safe Dams Program as an uncategorized dam. Disturbance of the buffer is necessary in order to allow for dam rehabilitation and ensure proper stormwater management. A Buffer Mitigation Plan and erosion control measures will be implemented to address major impacts. The proposed project will result in 105 total linear feet (23,464 total square feet) of buffer disturbance lasting approximately 5 months. The project is located on an unnamed impoundment of the Upper Ocmulgee Watershed (03070103).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
