Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

This project will consist of decommissioning two earthen dams on the proposed GreyStone Power Corporation – Corporate Campus located along Hiram Douglasville Highway in Paulding County. The dam decommissioning activities will include temporary impacts to two unnamed perennial streams downstream of the dewatering discharges for construction access and erosion and sedimentation controls (including a riprap plunge pool, rock filter dams and silt fencing). The proposed activities will result in approximately 45 linear feet total (16,986 square feet total) of buffer disturbances along two unnamed perennial streams, tributaries to Lick Log Creek in the *Middle Chattahoochee – Lake Harding Watershed*.
