This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves the improvement of the Industrial Blvd right-of-way to support residential development. A Buffer Mitigation plan and erosion control measures are implemented to address major impacts. The project will impact 72.74 linear feet (1,109.96 total square feet) of the 25-ft State Water buffer along an unnamed tributary to Lawrence Creek in the Etowah Watershed (03150104).
