Description and Location of Proposed Activity:

This project will result in the replacement of existing 8-inch sewer infrastructure currently located within the buffer. During construction, separate intrusions into the buffer include clearing for the pipe installation which will be approximately 20 feet wide to allow for construction access. The proposed project will impact 1,475.11 total linear feet (5,900.44 total square feet) of buffer disturbance along Boar Tusk Branch in the Upper Ocmulgee Watershed (03070103).
