Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This project will improve a drainage easement on 1.17 acres. Disturbance in the buffer is necessary to achieve drainage slope and drainage volume for the site. The impacts will be stabilized with native perennial vegetation. The proposed project will result in 26.5 total linear feet (260 total square feet) of buffer disturbance. The project is located at the intersection of Tift Avenue and 16<sup>th</sup> Street on an unnamed tributary to Westside Branch in the Withlacoochee Watershed (03110203).
