This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Perennial Stream (PS) 3 (unnamed tributary of Tanyard Creek) and PS 6 (Tanyard Creek). The project will widen the existing SR 1/US 27/Hamilton Road roadway from Auburn Street to the intersection with Fannin Street in City of LaGrange/Troup County, Georgia. The project will impact the state mandated 25-ft buffer within the Middle Chattahoochee-Lake Harding watershed (HUC 03130002). The disturbance will cover 8,617 square feet and include clearing, replacement and extension of culverts, placement of riprap, removal of reinforced concrete piping (RCP), and the installation of Best Management Practices (BMPs).

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
