Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Description and Location of Proposed Activity:

The proposed project involves the stabilization and restoration of the streambank and buffer. Disturbance of the buffer is unavoidable due to the nature of the project and necessary in order to prevent further erosional activity. A Buffer Mitigation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 90 total linear feet (2,170 total square feet) of buffer disturbance lasting approximately 2 months. The project is located on McFarland Branch (Rossville to Stateline) of the Chickamauga Watershed (06020001).
