Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered $\{391-3-7-.05(2)(a-k)\}$: (h)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to construct an electric vehicle, original equipment manufacturing facility. The site will accommodate vehicle production, product testing, battery cell production, distribution, training, employee services and associated infrastructure. The project will be located on a 2,003.23-acre site located adjacent to and north of Interstate 20, adjacent to and east of Highway 278 and adjacent to and west of Old Mill Road within Morgan and Walton Counties. The project will require 607 acres of disturbance including permanent impacts to 21,551.8 linear feet (815,007 square feet) of buffer along unnamed tributaries to Dennis Creek, unnamed tributaries to Hunnicut Creek, and an unnamed tributary to Rawlings Branch in the Upper Oconee River Watershed (HUC 03070101).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
