Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity: <u>Georgia Department of Transportation Project (GDOT) PI No.</u> 0007057 is a bridge replacement project in Warren County. The project will result in 1,365 square feet of non-exempt buffer impacts to the resource named Perennial Stream 2 (Short Creek), located in the Ogeechee River Watershed. All disturbed land will be revegetated with a native riparian grass seed mixture per GDOT's Standard Specification 700.
