Description and Location of Proposed Activity:

The proposed project will impact the buffer of Perennial Stream (PS) 2 (unnamed tributary to Canal Branch) and Intermittent Stream (IS) 4 (unnamed tributary to Canal Branch). The project will widen State Route (SR) 24/Fall Line Freeway from east of West Chambers Brooks Spring Road to west of Helton Lane in Washington County. The project will impact the state mandated 25-ft buffer within the Lower Oconee watershed (HUC 03070102). The disturbance will cover 1,012 square feet and include placement of riprap and the installation of Best Management Practices (BMPs).
