The proposed project will impact the buffer of Intermittent Stream (IS) 111, Buffered State Water (BSW) Y, Open Water (OW) 115, OW 120, OW 121, OW 123, OW 124, OW 126, BSW Z1, IS 128, Perennial Stream (PS) 143, OW 145, OW 146, and OW 148. The project will widen and reconstruct SR 133 from North of the Colquitt County line to North of SR 112 in Worth County. The project will impact the state mandated 25-ft buffer within the Upper Ochlockonee Watershed (HUC 03120002). The disturbance will cover 56,202 square feet and include roadway grading, clearing for construction access, roadway cut/fill, pavement removal, driveway construction, and the installation of Best Management Practices (BMPs).
