CATEGORICAL EXCLUSION DETERMINATION
Camilla Water Pollution Control Plant (WPCP) Upgrades
City of Camilla (Mitchell County)
GEFA Loan No. CW-2024-028

The Georgia Environmental Protection Division (EPD) has conducted a review of the above project in accordance with the State's Environmental Review Process (SERP). EPD has determined that this project is eligible for a categorical exclusion. Accordingly, no further environmental review is planned. The proposed project consists of dredging sludge in the oxidation pond as well as removal and disposal of dewatered sludge that is currently stored in geotubes at the WPCP. The City is also proposing to install a high efficiency electrical pumping system to replace diesel bypass pumps that transfer wastewater between ponds. Existing buildings will not be impacted as a result of this project. All construction will be located on City-owned property and/or existing right-of-ways. The project will not be located in the 100-year floodplain as indicated by the Federal Emergency Management Agency (FEMA) map.

This project is eligible for a categorical exclusion because it meets the following specific criteria, outlined in the SERP: minor rehabilitation of existing facilities. Furthermore: the project will not create a new or relocate an existing discharge to surface or ground waters; the project will not substantially increase the volume of discharge or loading of pollutants; the project will not provide capacity to serve a population 30% greater than the existing population; the project will not have a significant effect on the quality of the human environment; the action will not directly or indirectly affect cultural resources, habitats of endangered or threatened species, or environmentally important natural resource areas; and the action is cost-effective and should cause no significant public controversy.

This determination is effective immediately. This exclusion may be revoked at any time if: 1) the project is altered and no longer meets the requirements of a categorical exclusion, 2) new evidence shows that serious environmental issues exist, or 3) a local, State or Federal law is being or may be violated.
