NOTICE OF NO SIGNIFICANT IMPACT ON THE ENVIRONMENT TO ALL INTERESTED AGENCIES, GROUPS, AND PERSONS

The City of Lavonia has made an application to the Georgia Environmental Facilities Authority (GEFA) and the Georgia Department of Natural Resources, Environmental Protection Division (EPD) for a loan through the Drinking Water State Revolving Loan Fund (DWSRF). The loan is for the water system improvements project. The applicant has certified that the project is environmentally sound. As required by the Federal Safe Drinking Water Act and the Drinking Water State Revolving Fund Program Guidelines, an environmental review has been performed on the project described below:

Project Description

Under this project, the City of Lavonia will improve water supply and withdrawal components (systemwide SCADA); water treatment (Underdrains, media air scour, troughs, controls, conversion of chlorine gas to liquid sodium hypochlorite, clearwell No.1, finished water meter,); water storage and distribution system (elevated storage tank altitude valves, water main replacements and extensions).

Anticipated Impacts

The proposed project will have minimal impact on the environment as construction will be limited to the existing project site. This project will help to upgrade outdated and undersized components, to keep the system in good working order, to reduce water loss, to cover remotes areas, to anticipate and to meet the water demand.

A review of the Engineering Report and Environmental Information Document for the proposed project has been performed by EPD's Drinking Water Permitting and Engineering Program. A copy of these documents is available for public examination upon request at EPD between the hours of 8:30 a.m. and 4:00 p.m. Monday through Friday. The addresses where a copy is available are listed below.

During the development and design of this project, the City of Lavonia has solicited public input. The project has undergone an Executive Order 12372 Review through the State agencies. The project has also been submitted to the Corps of Engineers, State Historic Preservation Office, and the U.S. Fish and Wildlife Service for review. No adverse comments have been received. No further environmental review of the project is proposed to be conducted prior to the release of loan funds.
