Description and Location of Proposed Activity: <u>The proposed project will impact the buffer of Wetland (WL) 4</u> and WL 7. The project will replace the SR 25 bridge over the Savannah River in Chatham County. The project will impact the state mandated 25-ft buffer within the Lower Savannah River Watershed (HUC 03060109). The disturbance will cover 54,018 square feet and include construction access, roadway installation, installation of bridge structures, relocation of utilities, and the installation of Best Management Practices (BMPs).
