Description and Location of Proposed Activity: <u>This project will widen an approximately 6 mile section of SR 25/US 17 and reconstruct/replace two bridges.</u> The project has a total disturbed area of 46 acres in the <u>Brunswick River – Atlantic Ocean (HUC 0307020302) and Altamaha River – Atlantic Ocean (HUC 0307010605) Watersheds.</u> Disturbances will be mitigated for using onsite erosion control best management practices and the purchase of off site mitigation credits.
