This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-6 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.11 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves construction of a retaining wall along a property on Hawkins Island Circle in Glynn County. Land disturbing activities within the buffer of Hawkins Creek feature wooden wall installation, which is to be achieved with minimal machinery and completed with hand equipment, as well as revegetation practices. The retaining wall is intended to combat erosion along the coastal marshland – upland interface: the project aims to stabilize the bank and to retain the integrity of the property. Alternative practices were considered and deemed infeasible. This project requires 2,256 square feet of disturbance along 253 linear feet within the Cumberland – Saint Simons Watershed (03070203). Disturbed areas will be revegetated upon completion of the project.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
