Description and Location of Proposed Activity:

This project proposes to impact 238 linear feet (3,643 square feet) of buffer along an unnamed tributary that leads to Village Creek to construct a wooden bulkhead. The bulkhead to be constructed is to prevent further erosion of private property and will be stabilized with native grass. The project is located off Hopkey Avenue Drive on Sea Island.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
