This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-6 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.11 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

This project proposes to impact 216 linear feet (5,004 square feet) of buffer along an unnamed tributary that leads to Village Creek to construct a wooden bulkhead placed landward of Coastal Marshlands Protection Act jurisdiction. The bulkhead is intended to combat erosion and subsidence along the coastal marshland upland interface, stabilize the bank, and retain the integrity of the property. The bulkhead impact will be stabilized with native grass and native landscaping. The project is located off Oglethorpe Circle on Sea Island in the Cumberland-St. Simons Watershed (03070203).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
